

# REPAIRERS OF THE BREACH

## The High Moral Stakes of the Budget Debate

### *State-by-State Impacts of the House Reconciliation Bill*

On May 22, 2025, the House passed a [budget reconciliation bill](#) that would make the deepest cuts to Medicaid and the SNAP food assistance program in history. The bill would reduce federal Medicaid spending by about \$800 billion and SNAP by nearly \$300 billion through 2034, according to the [CBO](#). This table presents state-by-state data on total Medicaid and SNAP enrollees and their share of each state's total population. It also includes estimates of the number of people who would be expected to lose Medicaid and lose at least some SNAP benefits under the House-passed bill.
